The user-friendly interface guides users through small business and entrepreneurial subject areas, common business types, a help-and-advice section, and provides information on how to create business plans that lead to successful funding. Business videos provide critical information for business owners: interviews, 'lessons learned'

features, lectures and 'how to' videos help foster success in all aspects of managing a business. A collection of state-specific resources supports the researcher with demographic data and other local information.

**Consumer Health Complete**

Designed to provide health care information for the everyday consumer. It provides convenient access to easily understandable health and medical information. Consumers can search and browse within medical encyclopedias, health pamphlets, popular reference books, and magazine articles.



In addition, there are evidence-based health reports on diseases, conditions, injuries and procedures that consist of high-quality information written for the lay person. There is information on drugs and herbs, alternative health, plus videos and animations on men or women's health, aging, and general health issues.

**Friends' Booksale Collects \$200,000**

The recent 63rd Annual Friends of the Library of Hawaii Booksale, Hawaii's biggest and best booksale, collected approximately \$200,000. Proceeds from the sale benefit the Hawaii State Public Library System by providing public libraries and staff with books and equipment, performance programs, and continuing education grants.

More than 400 volunteers from various community groups and student organizations provided valuable assistance to the Friends for the 10-day booksale. In addition, the Friends' received more than \$21,000 in donations from local businesses, and food donations from Safeway and Zippy's Restaurants.

## New Online Databases are Available

Are you an avid newspaper reader? Do you want to start up a small business or need to expand your existing business? Are you looking for the latest information about health issues? If you are, check out the Hawaii State Public Library System's website ([www.librarieshawaii.org](http://www.librarieshawaii.org)) for these new online databases provided by EBSCOhost:

**Newspaper Source Plus**

More than 700 full-text newspapers, providing more than 31 million full-text articles. It contains comprehensive full text for major newspapers such as the New York Times (from January 1985 to present), Boston Globe, Christian Science Monitor, Irish Times (Ireland), San Francisco Chronicle, The Sydney Morning Herald (Australia), The Times (UK), Toronto Star, USA Today, The Washington Post, and The Washington Times (D.C.).



All staff articles are also included from many newspapers such as The Dallas Morning News, Houston Chronicle, Star Tribune (Minneapolis), The Philadelphia Inquirer, and The Seattle Times.

In addition, Newspaper Source Plus features more than 699,000 television and radio news transcripts such as

**A**ttention parents! Beginning August 5, 2010, overdue fines for children at Hawaii's public libraries will increase from 15 cents per item per day to 25 cents per item per day, the result of Administrative Rule changes being implemented by the Hawaii State Public Library System (HSPLS). The Board of Education (BOE) voted unanimously to approve the rule changes during their April 15, 2010 General Business Meeting.

The current maximum fine of \$4.50 per item for children (ages 17 years and under) will also increase to \$7.50 per item. By implementing this change, overdue fines and the maximum amount per item will be the same for all borrowers.

"There are three main benefits for converting to a uniform fee structure," said State Librarian Richard Burns. "A uniform fee structure is predictable and easy to remember; it will ensure fairness to all library patrons; and it will encourage all our patrons to borrow responsibly."

Parents can help their children keep track of due dates for loaned library materials on the HSPLS website ([www.librarieshawaii.org](http://www.librarieshawaii.org)): select the "Information" tab, click on the "My Account" tab, log in, and select "Checked Out." Of course, children who return library materials on time will not be affected by this rule change.

DVD and video borrowers will be happy to know that overdue fines for DVD/Video rentals will *decrease* from \$1.00 per DVD/Video per day to 25 cents per DVD/Video per day. The rental fee and loan period for DVDs and videos are \$1.00 per DVD/Video and seven days, respectively.

# Meet Award-winning Crime Novelist at Oahu Libraries

**A**ward-winning author **Douglas Corleone** will be featured in a "Meet the Author" program at five Oahu public libraries from August 4 – September 19.

Corleone, former New York City criminal defense attorney and current Kapolei resident, won the 2009 Minotaur Books/Mystery Writers of America First Crime Novel Award for the recently published "**One Man's Paradise**" (Minotaur Books, April 2010), a riveting legal thriller set on Oahu.

"One Man's Paradise" is the story of Kevin Corvelli, a disgraced criminal defense lawyer who flees Manhattan for Honolulu, only to learn that Paradise can be every bit as lethal as the City that Never Sleeps. Minotaur Books hailed this gripping tale of failure and the search for redemption as "... the stellar debut of an exciting new crime-writing voice."

Corleone is currently at work on the sequel to "One Man's Paradise," a novel tentatively titled "Night on Fire," in which Kevin Corvelli defends a young bride accused of arson at a popular Hawaiian Island resort.

## Library Rule Changes, from front page

Among other major rule changes that will affect library customers are:

- **Library Card.** A new library card application and renewal form will advise parents and guardians that they will be held financially responsible for any fines, fees or charges incurred by a minor whose library card application they are signing.
- **Replacement Library Card.** Hawaii Resident/Military: the cost for adults will decrease from \$10 to \$5. This change will make the \$5 cost consistent for both juveniles and adults.
- **Smoking is prohibited within 20 feet** of any entrance, exit, window or ventilation intake. This change is in compliance with Hawaii's Smoke-Free Law (Act 295) of 2006.
- **Alcoholic beverages are prohibited** on all library property.

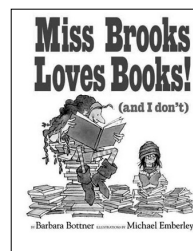

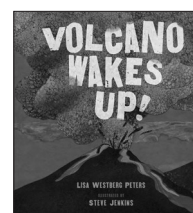
**Barbara Bottner**

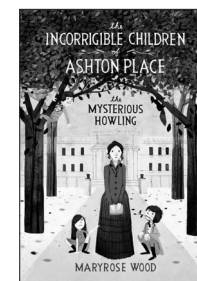
**Lenore Look**
