REGISTRATION INFORMATION

WHAT WE DO:

The Hawaii State Library for the Blind and Print Disabled (LBPD) lends reading materials in audio, braille and large print formats to eligible library users free of charge. You can choose to have materials mailed to you (for free) or you can download books to a computer or mobile device. LBPD is a branch of the Hawaii State Public Library System and the Pacific Regional Library for the National Library Service for the Blind and Print Disabled (NLS).

WHO IS ELIGIBLE:

- 1. Individuals with visual impairments, including those who are legally blind, those unable to read standard printed material with corrective lenses, and those who are unable to read comfortably without special aids or devices other than regular eye glasses.
- 2. Individuals with physical disabilities that prevent them from turning pages or holding a book because of muscle or nerve deterioration, paralysis or any other physical impairment.
- 3. Individuals with a reading disability resulting from an organic dysfunction, such as dyslexia, that prevents them from reading printed material in a normal manner.
- 4. Those with temporary conditions listed above.

- 5. Reading material and equipment may also be loaned to institutions such as nursing homes, hospitals, and schools for the blind provided they are used only by persons who meet the eligibility criteria. Students at public and private schools must be certified on an individual basis.
- 6. To qualify, applicants must be residents of the United States, including territories, insular possessions, and the District of Columbia, or American citizens living abroad.
- 7. For all LBPD services, preference shall be given at all times to eligible persons who have been honorably discharged from the armed forces of the United States.

HOW TO APPLY:

- 1. Complete the attached application form.
- 2. Have it signed by a "Competent Authority."
- 3. Submit the application to LBPD or any public library branch.

WHO IS A "COMPETENT AUTHORITY?"

1. A "Competent Authority" is a professional who can certify an applicant's disability. This includes doctors of medicine, doctors of osteopathy, ophthalmologists, optometrists, registered nurses, therapists, and professional staff of hospitals and public or welfare agencies (such as educators, social workers, counselors, rehabilitation teachers, certified reading specialists, school psychologists, or

superintendents). In the absence of any of these, certification may be made by professional librarians or by any person whose competence under specific circumstances is acceptable to NLS.

2. Applicants, or anyone related to them, may not consider themselves a competent authority and are not allowed to certify their own forms, including those borrowing for an institution or agency.

RESOURCES AVAILABLE:

- 1. **BOOKS:** Available from NLS in audio and braille formats.
- 2. **MAGAZINES:** Available from NLS in audio and braille formats. Direct mail subscriptions from the producer is available free of charge.
- 3. **DOWNLOADS:** Downloadable books and magazines in audio and electronic braille formats are available from **BARD**, the Braille and Audio Reading Download service provided by NLS. Library users must have access to a computer with an Internet connection, an email address, the ability to zip and unzip files, and a talking book machine, smartphone or similar device to read materials.
- 4. CATALOGS: Listings of new audio and braille books and magazines are available in audio, braille and large print formats. The catalog for audiobooks is called "Talking Book Topics," and the catalog for braille is "Braille Book Review." Direct mail subscriptions from the producer are available free of charge.

- 5. MACHINES: Special machines designed to play the audiobooks and magazines distributed by NLS are available. They provide high-quality sound, offer variable speed controls, and have built-in audio instructions for people with visual disabilities. Machine repair/replacement for malfunctioning NLS equipment is provided by LBPD.
- 6. **LARGE PRINT BOOKS:** Books in large print are available as part of the Hawaii State Public Library System collection. An HSPLS library card is required to borrow these materials.
- 7. **REGULAR PRINT MATERIALS ON DISABILITIES:** This collection is also part of the Hawaii State Public Library System. These books are published in standard print and not available in braille or audio. An HSPLS library card is required to borrow these materials.
- 8. RADIO READING SERVICE HAWAII (RRS): LBPD provides a closed circuit radio broadcast over a sub-channel of Hawaii Public Radio (KHPR), which can be heard on Oahu and Maui. Narrators read articles from local newspapers and magazines, grocery ads, locally produced books and more. Programming is broadcast 24 hours a day, 7 days a week. A special radio receiver from LBPD is required.
- TRANSCRIBING SERVICES: Upon request, LBPD can transcribe print material into braille and audio formats. Material may be transcribed only if not already available in the desired format.

10. **BOOKLISTS:** A list of new large print books is mailed out to registered patrons at least 4 times a year.

ELIGIBILITY AND CERTIFICATION

Eligibility Criteria:

Persons may be eligible to receive library materials if they fall into one of the following categories and are residents of the United States or American citizens living abroad:

- 1. Blind persons whose visual acuity is certified as being 20/200 or less in the better eye with correcting lenses, or whose widest diameter of visual field subtends an angular distance no greater than 20 degrees.
- 2. Persons with visual disabilities who are certified as being unable to read regular printed material, with correction and regardless of optical measurement.
- 3. Persons with physical disabilities who are certified as being unable to read or unable to use regular printed material because of physical limitations.
- 4. Persons certified as having reading disabilities resulting from organic dysfunctions and of sufficient severity to prevent reading regular printed material in a conventional manner.

Certifying Authority:

The administrator of the institution may serve as the certifying authority.

TO BE SIGNED AND COMPLETED BY CERTIFYING AUTHORITY:

I certify that the institution named serves people who are unable to read or use regular printed materials because of blindness, visual disability or physical limitation, and that the materials and equipment borrowed will be used by such persons only.

CLASSES OF BORROWERS

Veterans. In the lending of books, recordings, playback equipment, musical scores, instructional texts, and other specialized materials, preference shall be given at all times to the needs of blind and other physically disabled persons who have been honorably discharged from the armed forces of the United States.

Institutions. Institutions such as schools, residential care facilities, hospitals, and other establishments regularly attended by people who are blind or have a physical disability may borrow special format reading materials and playback equipment solely for the use of persons certified as eligible. These persons must be the direct and only recipients of the materials and equipment provided by the National Library Service for the Blind and Print Disabled.
